Thanks to generous support from corporations, foundations, individuals and law enforcement, The Partnership for a Drug-Free America, Arizona Chapter expanded its grassroots programs in 2006 and touched the lives of more Arizona families than ever before.

Accomplishments in 2006 include:

- \$1.8 million in donated educational public service advertising time and space from media, statewide. Including news stories and articles, we reached 100,000 Arizona youth and caregivers each day!
- 7,500 middle and high school students were reached through the Teen Partners program, a peer to peer education program addressing the hazards of drug use and importance of healthy living. Through teen outreach, an additional 144,000 individuals were reached with a drug prevention message.
- Expansion of our Healthcare Partners program based on our work with the American Academy of Pediatrics to train more physicians, residents, school nurses and school counselors. An estimated 287,000 youth patients, students and parents were beneficiaries of these trainings.
- Expansion of our Partnering with Families TM programs working with our volunteer Parent Partners to educate other parents and influencers of children about the latest drug trends and the importance of open dialogue with children. Arizona parents have been featured on The Today Show, Wall Street Journal, Ladies Home Journal and the BBC. Through in-person presentations alone, volunteers reached 2500 individuals.
- Development and funding for our new Community Alliance Program. To be launched in 2007, this program provides training, public awareness strategies and resource materials to rural communities and partners dedicated to helping Arizona families live healthy, drug-free lives.

- Generation Rx the trend of teen misuse and abuse of prescription and over the counter drugs;
- Continued focus on preventing the devastating effects of methamphetamine on our communities;
- Building on our successful prevention initiatives to protect Arizona's most valuable asset its children!

Chapter Launches Statewide Drug Prevention Network

The Partnership for a Drug-Free America, Arizona Chapter has launched the Community Alliance Program thanks to grants from Thunderbirds Charities and the Phelps Dodge Foundation. For the first time, The Partnership's proven effective drug prevention information and resources will be shared with Community Alliance Program members across the state in a systematic way. By becoming an alliance member, organizations will be provided with the most up to date research and information on drug trends, public awareness and media materials. Members will also receive trainings on a regular basis with the goal of preventing and reducing Arizona's youth experimentation and use of drugs. The Arizona Chapter is currently reviewing requests from counties or organizations wishing to join the program.

The Arizona Chapter has received feedback from partners around the state about the need to increase public awareness about the critical importance of drug prevention and especially to keep up with the current trends. "The Community Alliance Program will allow The Partnership to share its expertise in an efficient and effective manner and most important, we look forward to long-term strategic partnerships with organizations that are committed to prevention", says Leslie Bloom, executive director of the Arizona Chapter.

PARENT TO PARENT

My nightmare began Valentine's day 2003 when I received a call from my son's assistant principal at his high school asking if I could come down to the school as she thought my son was using drugs.

I learned that my son started smoking cigarettes at the age of 13. He then progressed to pot, prescription drugs and ultimately his drug of choice was Methamphetamine.

I'm sure that when he started using meth, he didn't intend to have an addiction; he just wanted to escape his feelings and get high. However, in trying meth, he gained an almost deadly addiction that he will battle for the rest of his life.


My son is from a family that has two loving parents and a devoted sister and brother. He went to good schools and whatever he was involved in, we were involved in. The one thing that we were not counting on was his involvement with meth. As a mother, this experience has evoked many feelings from me that included guilt, worry, anger, pain and determination.

Today, after two treatment programs, he is two years free of methamphetamine. He attends college full-time in the evenings to obtain a drafting degree and works full-time at an engineering firm. He works a 12 step program with his sponsor and has made amends to his brother, sister, dad and myself. Our family is healing again, but I continue to worry. Even though my son today is doing well, there is not one day that goes by that I wonder if this drug will take him again.
